With the purchase of this Firearm Protection Program, SAS warrants the original purchaser of the firearm on attached receipt, that your firearm will be free from defects for one/five years after the original date of firearm purchase at SAS. This warranty applies to the function of the firearm only and does not include cosmetics/finish, optics, electronics, lasers, lights, tritium sights or accessories that are mounted to or integrated into the firearm.

We will repair, or have repaired, any defect in material or workmanship without charge to the purchaser – this includes shipping cost for repairs sent to the manufacturer.

**This warranty excludes damage caused by:**

- Failure to provide proper care or maintenance
- Accidents, abuse or misuse
- Barrel obstruction
- Hand loaded, reloaded or improper ammunition
- Unauthorized adjustments, repairs or modifications
- Normal wear and tear

To make a claim, bring your copy of the warranty with your original SAS receipt for your firearm stapled in it and your firearm to our store within the appropriate warranty period.

We will, at the discretion of SAS, repair the defect(s) at no cost to you. In the event a firearm cannot be repaired, or is too costly to repair, SAS reserves the right to replace the firearm with a comparable product of like kind and quality, or totally refund the original purchase price of the original firearm to an SAS gift card. Replacement products may be new or rebuilt to meet the manufacturer's specifications of the original product at the discretion of SAS. Decisions on repair, replacement or buyout are made solely at the discretion of SAS. Should SAS opt to replace the firearm, SAS will keep the defective one. Any firearm replacement will result in our customer filling out new background check paperwork and adhering to all State and Federal laws pertaining to a firearm transaction.

Qualifying warranty coverage will only be extended to the firearm listed on the purchase receipt. This warranty and the underlying warranties it extends are your exclusive remedy in the event of product defects. SAS specifically excludes any other expressed or implied warranties.

This Program is inclusive of the manufacturer's warranty; it does not replace the manufacturer's warranty, but provides certain additional benefits during the term of the manufacturer's warranty. After the manufacturer's warranty expires, this Program continues to provide the manufacturer's benefits as well as certain additional benefits listed within these terms and conditions.

SAS will under no circumstances pay any incidental or consequential damages which are specifically excluded from this warranty. This exclusion applies to any damages of any sort other than the repair or replacement remedy specifically provided above and it applies whether or not it is claimed that SAS was negligent or otherwise at fault.
